**England Golf & Midland Golf Union – Paul Keeling, Voting Member**

**ENGLAND GOLF & MIDLAND GOLF UNION REPORT FOR NUGC EXECUTIVE - October 2024**

**AGM General Business**

I'm sure you will be pleased to hear that the stalemate between England Golf & Woodhall Spa Land Holdings (WSLH) regards the development at the National Golf Centre has been resolved following

an extraordinary general meeting being called by shareholders, and the resolution for to amend the WSLH constitution to bring it in line with the 60% WSLH/40% EG representation being carried.

While there are still legal matters to be addressed which includes allowing for WSLH to take out finance, work by both sides is underway and it is hoped that construction work will commence autumn 2025.

Rounds played and visitor spend are both down compared to last year. It is hoped this is due to the weather and course conditions through winter 2023 and early spring 2024 but is something EG are closely monitoring.

The EG Strategic Plan 2025/2030 will be an evolution on the course planner, with the draft being made available to voting members in November and finalised the March General Meeting.

The new EG Terms of Affiliation had now been adopted by 1200 clubs, with others working towards, except for 47 clubs who had not engaged.

Both within the CEO's and Chairs report there was an emphasis on men's unions and ladies' associations revisiting merging using Lancashire's recent merger as a 'flag ship' to others. I will leave it to Council to further consider this matter.

### **Finance**

EG affiliation fee will rise by 75p from 1<sup>st</sup> January 2025

While actual versus budget year shows a surplus of £221K, which is from I Golf subscriptions and staff cost savings, affiliation fees are £97K down.

Following the county treasurers meeting, changes to the affiliation fee collection process which include penalties for clubs not paying over on time was approved.

### **MIDLAND GOLF UNION**

The date for the 2025 Mid-Amateur Open has been moved following discussion to Friday 30<sup>th</sup> May.

Due to illness director John Rawson has resigned from the MGU Board, an interim director has been co-opted until the MGU AGM on 4<sup>th</sup> December.

Players have requested consultation between counties and MGU regarding suitable venues for MGU seniors' events. Colin Bee may have further detail from seniors committee minutes.

I will be attending the MGU AGM at Chevin GC on 4<sup>th</sup> December and will update on director elections & financial statement soon after.

This tournament was played at the Manor GC, Uttoxeter on Sun 29 Sept. We fielded a very strong team but were no match for the team from Derbyshire who ran out convincing winners. The Notts boys all played well and as a team ended up in 5<sup>th</sup> place.

## **MGU Champion of Champions**

This tournament was played at Stourbridge GC on Sun 22 Sept in very poor weather. The County was represented by Kai Krishnan, Ethan Wan and William Psenko who all acquitted themselves very well – William Psenko who won the U14 and U16 championships and was overall runner up – a fantastic achievement.
